



INFORMATION NOTICE PURSUANT TO ARTICLE 13 OF EU REGULATION 2016/679

Article 13 of “EU Regulation on the protection of natural persons with regard to the processing of personal data and on the free movement of such data” imposes the obligation of providing the data subject with information on the fundamental elements of the processing.

1. DATA CONTROLLER

2. PURPOSES OF THE PROCESSING AND LEGAL BASIS

The legal basis for the processing of your data, which will be collected and stored with regard to the filling in of this form, is your consent; the processing is performed so that MECOME SRL may analyse and reply to your requests, and send informational and commercial messages, with your prior consent.

Your consent to the processing of data by ticking the checkbox is optional, but indispensable for sending the form.

3. RECIPIENTS OF THE DATA

Within the limits of the aforementioned purposes for the processing, your data may be communicated to companies/persons that provide outsourced services, duly appointed as Data Processors.

4. TRANSFER OF DATA OUTSIDE THE EU

The data you provide will not be transferred to Countries that are not members of the European Union.

5. RETENTION PERIOD

The data collected will be retained for the period of time necessary for the provision of the requested service and for another 10 years after that, in order to maintain an information relationship with the data subject (via newsletters, etc.), if the data subject has expressed his/her consent to the processing of the data provided for marketing purposes. After such time, the data will be permanently deleted.

6. RIGHTS OF THE DATA SUBJECT

The data subject may at any time exercise towards the Data Controller the rights of articles 15 et seq. of Regulation EU 679/2016: the right of access (art. 15); the right to rectification (art. 16); the right to erasure (art. 17); the right to restriction of processing (art. 18); the right to portability of data (art. 20); the right to object (art. 21); the right to withdraw consent (art. 13). The Data Subject may also always lodge a complaint with the competent Supervisory Authority (pursuant to art. 77 of Regulation EU 679/2016) or exercise the right to an effective judicial remedy (pursuant to art. 79 of Regulation EU 679/2016), if the Data Subject believes that his/her rights have been violated.
